BUY BACK AND CANCELLATION OF EMPLOYEE SHARE PLAN LOAN-FUNDED SHARES

Adherium Limited (ASX:ADR) confirms 7,258,581 ordinary shares have now been cancelled as per the previous notification (refer Appendices 3E and 3F lodged 11th June 2019). Following this cancellation, the total number of ordinary shares on issue and listed is 167,015,351.

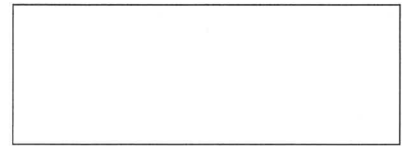
